Request for Proposal

Background

The 65th District Family Intervention Drug Court Program was developed in 1999 and the Family Preservation Drug Court in 2005. The focus of the Family Drug Courts is to reunify families and maintain a drug free life. The program provides collaborative and coordinated case management and treatment services to parents who have had their children removed or those at risk of having their children removed through the civil court process due to an open case with Child Protective Services. The mission is to provide parents the tools for a sober life and ability to accept the role of a parent. The Program is divided into three phases each with a set of specific requirements for successful completion, and closure of their CPS case.

Purpose:

To provide "Strengthening Families Program" (evidence based program) to parents and children involved in the Family Drug Court. The program will assist the families in becoming stable, and more effective in their roles as parents, sons/daughters, and avoid further involvement with the CPS System and substance use and abuse. Vendors must be able to adequately provide quality services to parents and children with complex issues presented by substance abuse, neglect, physical abuse, adolescent issues and provide the families considerable flexibility in the design and delivery of strength based interventions.

Other Requirements:

Services must be provided in the language of literacy and understanding to the parent and children.

Vendor must implement the "Strengthening Families Program" curriculum.

Meet with Drug Court team on a weekly basis for court staffing; meet on a quarterly basis to address any issues that may hinder the effectiveness of treatment services being provided.

A typed progress report two days before each court hearing. Failure to submit progress reports in a timely manner will result in non-payment for services.

Progress reports submitted to the Drug Court Coordinator/Case manager will incorporate information necessary to make an acceptable determination of family's progress or lack of progress at each staffing. Vender will be responsible for informing clients of limited confidentiality issues regarding progress or lack of progress. Vendor will be obligated to report to the Drug Court staff any active drug use.

An action plan shall be provided for any areas in which the family is not progressing. This Action Plan will be created with family, and team input with copies being distributed to all parties.

Progress must be based on specific measurable objectives, observable changes, and demonstrated ability to apply changes in current situation.

Services must be available on evening and weekends.

A pre and post test must be completed and submitted to the Drug Court Coordinator/Casemanager for determination of progression or regression of the client.

The Vendor must be available to communicate and staff cases with the Drug Court Team prior to each court hearing.

A progress report may also be requested at anytime by the Drug Court. The progress report shall identify progress or lack of progress that is based on clearly specified objective criteria, refusal or failure to attend or participate in treatment, failing to abide by the client's treatment plan and/or contract, or any disclosures regarding issues shall be clearly documented in treatment records.

Vendor will provide the Strengthening Families Program (SFP) curriculum. SFP sessions include all the critical core components of effective evidence-based parenting programs (CDC, 2008) including: parent and child practice time in the family sessions learning positive interactions, communication, and effective discipline.

The parenting sessions review appropriate developmental expectations, teach parents to interact positively with children (such as showing enthusiasm and attention for good behavior and letting the child take the lead in play activities, increasing attention and praise for positive children's behaviors, positive family communication including active listening and reducing criticism and sarcasm, family meetings to improve order and organization, and effective and consistent discipline including consequences and time-outs.

Vendor will provide services to 45 clients and their children.

Drug Court Coordinator/Case manager will be immediately notified in writing via e-mail or telephonically of all crisis calls and outcomes. Vendor will identify and include in their action plan method of addressing these issues.

Vendor must provide the Family Drug Court an analysis of how vendor will complete proposed goals, objectives, activities and outcome measures of the program being used in provided services to the families. Additionally the criteria utilized will define what composes a successful and unsuccessful closure of services from the vendor and must be submitted as part of this bid proposal.

Services

Purpose: Must use the nationally and internationally recognized parenting and family strengthening program for high-risk families. SFP is an evidence-based family skills training program found to significantly reduce problem behaviors, delinquency, and alcohol and drug abuse in children and to improve social competencies and school performance. Child maltreatment also decreases as parents strengthen bonds with their children and learn more effective parenting skills.

All services must be provided by tranined and experience counselors.

Proposal submission

The original plus (4) copies of an applicant's proposal must be received by the El Paso County Purchasing Department at the address indicated. Request for Proposal package no later than indicated by purchasing, at 12:00 p.m. Mountain Day light Savings Time. A representative at the Purchasing Department will date-stamp and time-stamp every proposal received immediately upon receipt. All proposals received before the proposal submission deadline will be kept in a secure location until the due date and time. The applicant's original proposal must be unbound with no staples, paper clips, fasteners, or heavy or lightweight paper stock within the document itself. It may be necessary to reproduce the original application to provide sufficient copies for review purposes. Therefore, the applicant should not include anything that cannot be photocopied using automatic processors. Such items include anything stapled, folded, pasted, or in a size other than 8 ½" x 11" on white paper and heavy or light weight paper which could disable in the photocopy machine and/or become destroyed. Odd sized attachments of any kind will not be copied or sent to reviewers. Excessive or over-sized material, e.g., posters, videotapes, audiotape, or CD's should not be included. Documents may be photo-reduced or have type closer than 15 characters per inch. Furthermore, only one side of each page should have printing.

BID FORMAT

Each applicant may submit one bid. The Bid must be submitted as an original plus four (4) copies.

Application materials could accidentally get out of order when being processed, thus every sheet of the Bid must have a page number. BID EVALUATION

A representative from the El Paso County Purchasing Department will open the bids immediately after the deadline and will record them. A representative from the Family Drug Court will perform a preliminary review of the bids to determine compliance with the mandatory requirements of this Bid. A team of individuals from the El Paso County will review and score all bids.

The contents of any bid shall be kept confidential during the evaluation process. All bids received by the El Paso County Purchasing Department on or before the submission deadline shall become the property of the El Paso County Family Drug Court and shall not be returned to the applicant. The El Paso County Family Drug Court shall have the right to use any or all ideas contained in the bid. Acceptance or rejection of a bid shall not affect this right.

Tex. Local Gov't Code § 176.006 (2005)

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

Tex. Local Gov't Code § 176.001 (2005)

§176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
