# IMPORTANT NOTICE FOR VENDORS

## EL PASO COUNTY CODE OF ETHICS TRAINING REQUIREMENT FOR VENDORS

**Vendors.** Any vendor involved in a single procurement exceeding \$50,000 must complete training on the El Paso County Code of Ethics. **This training must be completed prior to submitting a bid or proposal, responding to a request for qualifications or proposals, or otherwise contracting with the county.** The training must be completed by an officer, principal, or other person with the authority to bind the vendor. The certification of completed training on the Ethics Code issued by the County Human Resources Department is valid for one (1) calendar year from the date of completion. A list of those Vendors with a current certification of completion and the corresponding date of expiration shall be maintained on the El Paso County website under the Purchasing Department's Current List of Training Certified Bidders. This training requirement does not apply to emergency purchases.

### Training

In compliance with Section 161 of the Texas Local Government Code, training on the El Paso County Code of Ethics will be accessible in an online format to Vendors and Lobbyists on an ongoing basis, subject only to limitations due to technical resources. No person or entity required to complete training will have to do so more than once per year.

The contractor shall submit a **(3) three-year** proposal for the annual maintenance services of two ONAN emergency power diesel generator sets. The units are located at the El Paso County Detention Facility.

The proposal shall include the following:

- a. Performance of operations necessary to service the generator sets
- b. All charges for parts and equipment listed within these specifications
- c. All freight, shipping and handling charges for required replacement parts and materials
- d. All labor charges, including compensation for required overtime
- e. Travel expense, lodging and meals
- f. Charges for rental equipment and cars

## **1. Background Information**

The El Paso County Detention Facility is located at 601 East Overland Street, in El Paso, Texas, 79901. The emergency generator equipment, manufactured by ONAN Company, consists of two 900 KW diesel generator sets, 2 ONAN 400-Ampere transfer switches, 2 ONAN 1200-Ampere transfer switches and 4 remote control and monitoring panels. Since the start-up of the generators in 1993, the units have always been serviced by authorized service provider companies. All inspections and required tests of the units are current. The inspection reports may be reviewed at the office of the maintenance section supervisor.

## **2. Description of the Generator Units**

## **3. Walkthrough, Mandatory**

The contractor shall contact the Maintenance Foreman at (915) 546-2238 to make an appointment to take measurements and to evaluate the project.

The contractor shall provide a minimum of 24 hours notice. The walk-through shall be scheduled during normal business hours; Monday through Friday, 07:00 to 15:00 hours. Access to the facility will not be provided without an appointment. The contractor may not ask questions at the time of the walk-through; all questions must be submitted to the County Purchasing Department before the deadline.

## **4. Minimum Service Requirements**

### **4.1 General**

Visually inspect site and equipment. Inspect entire system for oil, fuel and coolant leaks.

### **4.2 First Scheduled Service**

During the first scheduled service, the contractor shall complete the following listed work:

- a. Replace water filter mounting assembly - Generator #2
- b. Repair exhaust leak – Generator #2
- c. Clean radiator and install new radiator cap – both units
- d. Replace fan belt – both units
- e. Replace defective warning light bulbs – both units
- f. Measure output voltage and frequency with calibrated test equipment – adjust as needed and submit written report
- g. Replace any defective and/or malfunctioning monitoring meters

### **4.3 Cooling System**

Inspect cooling system for leaks and restrictions.

Inspect water hoses and hose connections.

Inspect block heaters for proper operations.

Replace coolant filters with new Fleetguard filters.

Inspect and adjust Fan / Alternator Belts. Submit a written repair quotation if the belts are worn out.

Run engine and document operating temperature.

**Replace coolant mixture every two years.**

**(Last replaced 2011 – next replacement due 2013)**

Use only manufacturer recommended antifreeze. Measure and document the strength of the new coolant solution. Meet manufacturer's recommendations.

Inspect radiators

Take coolant sample and submit the sample to a laboratory for analysis.

Submit written report, including the laboratory findings.

### **4.4 Lubrication System**

Check oil and document oil pressure for start, warm up and run operations.

**Every year, replace engine oil.** Use only manufacturer recommended lubricants.

Replace oil filters with new Fleetguard filters.

Take oil sample and submit the sample to a laboratory for analysis. Submit written report of the laboratory findings.

### **4.5 Diesel Fuel**

Replace fuel filters. Take fuel sample and submit the sample to a laboratory for analysis. Submit written report of the laboratory findings.



#### **4.6 Governor**

Inspect linkage and ball joints. Check for vibration and/or noise. Replace oil in governor unit.

#### **4.7 Exhaust System**

Inspect the engine exhaust system for leaks and restrictions. Inspect mufflers, exhaust pipes, supports and connections.  
Submit written report.

#### **4.8 Electrical System**

Inspect starting system, batteries and cables. Record specific gravity readings. Clean battery terminals. Check battery-charging rate. Report conditions of the battery sets. Clean and remove debris from the electrical cabinets.

**Replace all batteries every three years.**

**(Last replaced 2010 – next replacement due 2013)**

Submit written report.

#### **4.9 Generator**

Inspect and clean ventilation screens.

Inspect insulation, check for unusual noise and tighten covers.

Inspect engine and generator controls and all instruments.

Adjust frequency and voltage as outlined by the manufacturer.

Record voltage and frequency readings during test run.

Report readings

Vacuum and clean generator control enclosures.

Submit written report

#### **4.10 Electrical Equipment**

Inspect and operate circuit breakers manually

Inspect bus bar and feeder connections

Inspect transfer switch connections

Inspect insulation

Inspect the Automatic Transfer Switches

Vacuum and clean transfer switch enclosures

Submit written report

#### **4.11 Remote Monitoring Equipment**

Remote control and monitoring panels are installed inside the basement boiler room and inside the central security office at the first floor of the facility. The contractor shall inspect these units for proper operations and shall submit a written inspection report.

#### **4.12 Laboratory Reports**

Take oil, fuel and water samples and submit samples to a laboratory for analysis. Submit written report of the laboratory findings.

### Oil Analysis

Physical Tests: Viscosity, SAE Grade, Fuel Soot, Water, Fuel or Antifreeze Dilutions  
Wear Metal, PPM  
Additives and other metals, PPM

### Fuel Analysis

Ignition quality of the fuel, % Sulfur, API Gravity, Cloud Point, Pour Point, Bacteria and presence of Water

### Coolant Analysis

Freeze Point, Visual, PH, Glycol, Boil Point, Nitrite, Specific Conductance, Foam and Dissolved Solids

#### **4.13 EPA Requirements**

The contractor shall follow all applicable EPA requirements when disposing of oil, antifreeze solution and lubricants, and shall maintain written disposal records.

#### **4.14 MSD Sheets**

The contractor shall provide MSD sheets for all chemicals, lubricants and antifreeze that may be used during the service.

#### **4.15 Inspection Report**

Submit a report of all deficiencies found during the service. Include a written repair estimate.

### **5. General Requirements**

#### **5.1 Regulations / Code Requirements**

All work shall conform to all applicable, building, mechanical, plumbing, fire and electrical codes and regulations.  
Obtain all necessary permits and licenses.

#### **5.2 Technicians / Engineers**

The engineers conducting the services must be well experienced with Cummins emergency power generators. If requested by the County representative, the contractor shall submit written training and work experience documentation for the technicians conducting the service work.

#### **5.3 Test Equipment**

Only suitable test equipment shall be used.

#### **5.4 Manuals**

The contractor shall utilize maintenance, maintenance supplement, installation and operation manuals and other equipment related

publications, issued by the equipment manufacturer, which may be required to conduct the work.

### **5.5 Reports**

Submit reports as outlined throughout Section 3. In particular, Sections 3.11 and 3.12.

### **5.6 Schedules**

The contractor shall submit an accurate time schedule for the project; including the following information:

- The scheduled arrival of equipment, parts and material.
- Time required for the completion of the scheduled service.

### **5.7 Facility Operation**

The operation of the Detention Facility may only be interrupted during nighttime hours and these interruptions shall be limited in time. 24 hours notice for scheduled, time limited, power outages shall be submitted. Possible interruptions to the following listed functions must be held to a minimum: Feeding of inmates, movement of officers and inmates, booking and releasing of inmates, use of computer and fiber optic equipment.

### **5.8 Background Investigation**

The contractor shall submit a list of employees, who will execute the work inside the Detention Facility, for a background investigation, with the following information to the El Paso County Sheriff's Department Identification and Records Section.

- Name of employee: first, middle and last name
- Employee's home address
- Employee's date of birth
- Employee's drivers license number

The Sheriff may deny access to security areas to any employee who failed the background investigation.

### **5.9 Tools and Test Equipment**

All tools brought into the Detention Facility must be checked in and out. Therefore, employees of the contractor must supply a complete inventory list of their tools, power tools, and test equipment.

### **5.10 Searches**

All persons and their belongings may be subjected to inspections and/or searches.

### **5.11 Parking**

All contractor vehicles, required to conduct the work inside the Detention Facility, shall be parked off site at the contractor's expense.

### **5.12 Cleaning**

Keep work areas clean. Remove and properly dispose of all packing material and debris at the end of each workday.

### **5.13 Tobacco Products**

The El Paso County Detention Facility is a smoke free facility. Contractor employees shall not enter the facility carrying tobacco products.

## **6. Contract Requirements**

### **6.1 Contract Period**

The contractor shall submit a proposal for a **(3) three -year** service agreement.

The contract time frame shall coincide with the El Paso County's fiscal budget year, October 1<sup>st</sup> through September 30<sup>th</sup>.

1<sup>st</sup> Year: October 01, 2011 through September 30, 2012

2<sup>nd</sup> Year: October 01, 2012 through September 30, 2013

3<sup>rd</sup> Year: October 01, 2013 through September 30, 2014

The duties of the Contractor shall commence on **October 1, 2011 and end on September 30, 2014.**

### **6.2 Working Hours**

The work required may be conducted within the following time periods: Monday through Friday, 07:00 - 15:00 Hrs., (7:00 A.M. - 3:00 P.M.)

### **6.3 Compensation and Invoices**

- a. Unless otherwise agreed upon in writing by the parties, the County's maximum liability for all services performed during the term of this Agreement shall not exceed the amount awarded with the purchase order.
- b. The Contractor shall be compensated for actual services provided.
- c. The compensation paid to the Contractor under this Agreement includes all fees and expenses incurred while performing services under this Agreement.
- d. During each service year, the Contractor shall submit **one invoice** for services rendered.
- e. The County shall pay the Contractor within 30 days following receipt of each invoice.

#### **6.4 Independent Contractor**

The Contractor is an independent contractor, and neither the Contractor nor Contractor's staff is, or shall be deemed, county employees.

#### **6.5 Termination of Agreement**

If at any time after commencement of the services required by this Agreement, the County shall, in its sole reasonable judgment, determine that such services are inadequate, unsatisfactory, no longer needed or substantially not conforming to the descriptions, warranties or representations contained in this Agreement, the County may terminate this Agreement upon 30 days written notice to Contractor.

#### **6.6 Indemnification**

The Contractor agrees to indemnify and hold the County, its officers, agents, and employees harmless against, any claims, demands, damages, costs, and expenses (including reasonable attorney's fees for defending the claims and demands) for injury or damage to the person or property of any other party arising out of any act or failure to act by the Contractor, its officers, agents, contractors, or employees, or the condition of any equipment owned by the Contractor.

#### **6.7 General Provisions**

- a. Sole agreement: This is the entire Agreement between the Contractor and the County. No contract or proposal submitted by the contractor shall supersede the requirements outlined in these specifications.
- b. Severability: If any part of this Agreement is held unenforceable, the rest of the Agreement will continue in full force and effect.
- c. Applicable law: The laws of the State of Texas shall govern this Agreement, and venue shall be El Paso County.
- d. Notices: All notices and other communications given in connection with this Agreement shall be in writing and shall be deemed given as follows:

Notices shall be deemed given when delivered personally to the recipient's address, or three days after being deposited in the United States mails, postage prepaid to the recipient's address.

- e. No partnership: This Agreement does not create a partnership relationship; the Contractor does not have authority to enter into contracts on behalf of the County.
- f. Assignment: The Contractor Company may not assign its rights or obligations under this Agreement without the County's prior written consent. The County may freely assign its rights and obligations under this Agreement.
- g. Amendment. This agreement may not be amended or modified, except by a writing executed by both parties hereto.

**6.8 General Liability Insurance**

The contractor shall provide and maintain General Liability Insurance coverage during the contract time period.

Limits:

**6.9 Worker’s Compensation and Employers’ Liability**

The contractor shall provide and maintain Worker’s Compensation and Employers’ Liability Insurance coverage. The County of El Paso must be notified in the event that the insurance policy is changed or canceled.

**6.10 Automobile Liability Insurance**

The contractor shall provide and maintain Automobile Liability Insurance for contractor owned or operated motor vehicles operating on property belonging to the County of El Paso. The County of El Paso must be notified in the event that the insurance policy is changed or canceled.

Limits: Shall meet or exceed the requirements outlined by the State of Texas.

Instructions for the certifications:

### General Requirements

The County of El Paso, Texas is required to obtain from all applicants of federal funds or pass-through certifications regarding federal debt status, debarment and suspension, and a drug free workplace. Institutional applicants are required to certify that they will comply with the nondiscrimination statutes and implementing regulations.

Applicants should refer to the regulations cited below to determine the certifications to which they are required to attest. Signature of the form provides for compliance with certification requirements under 21 CFR part 1405, "New Restrictions on Lobbying," 21 CFR part 1414, Government wide Debarment and Suspension (Non procurement), Certification Regarding Federal Debt Status (OMB Circular A-129), and Certification Regarding the Nondiscrimination Statutes and Implementing Regulations. The certifications shall be treated as a material representation of fact upon which reliance will be placed when the County of El Paso determines to award the covered cooperative agreement

### 1. LOBBYING

As required by Section 1352, Title 31 of the U.S. Code, and implemented in 21 CFR part 1405, for persons entering into a cooperative agreement over \$100,000, as defined at 21 CFR Part 1405, the applicant certifies that;

(a) No federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any agency, a member of Congress, and officer or employee of Congress, or an employee of a Member of Congress in connection with the making of any Federal grant, the entering into continuation, renewal, amendment, or modification of any Federal grant or cooperative agreement,

(b) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal Grant or cooperative agreement, the undersigned shall complete and submit Standard Form -LLL, "Disclosure of Lobbying Activities," in accordance with its instructions;

(c) The undersigned shall require that the language of this certification be included in the award document for all sub-awards at all tiers (including sub-grants, contracts under grants and cooperative agreements, and subcontracts) and that all sub-recipients shall certify and disclose accordingly.

### 1. DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

As required by Executive Order 12549, Debarment and Suspension and implemented at 21 CFR Part 1404, for prospective participants in primary covered transactions

A. The applicant certifies that it and its principals:

(a) Are not presently debarred, suspended, proposed for debarment, declared ineligible, sentenced to a denial of Federal benefits by a State or Federal court, or voluntarily excluded from covered transactions by any Federal department or agency;

(b) Have not within a three-year period preceding this application been convicted of or and a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain or performing a public (Federal, State, or local) transaction or contract under a public transaction violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property;

(c) Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State, or local) terminated for cause or default; and

B. Where the applicant is unable to certify to any of the statements in this certification, he or she shall attach an explanation to the application.

## 2. DRUG-FREE WORKPLACE

As required by the Drug Free Workplace Act of 1988, and implemented at 21 CFR Part 1404 Subpart F.

A. The applicant certifies that it will or will continue to provide a drug free workplace by:

(a). Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the applicant's workplace and specifying the actions that will be taken against employees for violations of such prohibition;

(b) Establishing an on-going drug free awareness program to inform employees about:  
(1) The dangers of drug abuse in the workplace;

(c) Making it a requirement that each employee to be engaged in the performance of the grant be given a copy of the statement required by paragraph

(d) Notifying the employee in the statement required by paragraph (a) that, as a condition of employment under the grant, the employee must

- (1) Abide by the terms of the statement; and
- (2) Notify the employer in writing of his or her conviction for a violation of a criminal drug statute occurring in the workplace no later than five calendar days after such conviction.

(e) Notifying the agency, in writing, within 10 calendar days after receiving notice under subparagraph (d)(2) from an employee or otherwise receiving actual notice of such convictions. Employers of convicted employees must provide notice including position title, to: The County of El Paso, Texas, 500 East San Antonio Street, Suite 406, El Paso, Texas 79901. Notice shall include the identification number of each affected grant

(f) Taking one of the following actions within 30 calendar days of receiving notice under subparagraph (d)(2), with respect to any employee who is so convicted:

- (1) Taking appropriate personnel action against such an employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973, as amended; or



(2) Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal State, or local health, law enforcement, or other appropriate agency

(g) Making a good faith effort to continue to maintain a drug free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

3. CERTIFICATION REGARDING FEDERAL DEBT STATUS (OMB Circular A-129)

The Applicant certifies to the best of its knowledge and belief, that it is not delinquent in the repayment of any federal debt.

4. CERTIFICATION REGARDING THE NONDISCRIMINATION STATUTES AND IMPLEMENTING REGULATIONS

**Tex. Local Gov't Code § 176.006 (2005)**

§ 176.006. Disclosure Requirements for Vendors and Other Persons; Questionnaire

(a) A person described by Section 176.002(a) shall file a completed conflict of interest questionnaire with the appropriate records administrator not later than the seventh business day after the date that the person:

(1) begins contract discussions or negotiations with the local governmental entity; or

(2) submits to the local governmental entity an application, response to a request for proposals or bids, correspondence, or another writing related to a potential agreement with the local governmental entity.

(b) The commission shall adopt a conflict of interest questionnaire for use under this section that requires disclosure of a person's affiliations or business relationships that might cause a conflict of interest with a local governmental entity.

(c) The questionnaire adopted under Subsection (b) must require, for the local governmental entity with respect to which the questionnaire is filed, that the person filing the questionnaire:

(1) describe each affiliation or business relationship the person has with each local government officer of the local governmental entity;

(2) identify each affiliation or business relationship described by Subdivision (1) with respect to which the local government officer receives, or is likely to receive, taxable income from the person filing the questionnaire;

(3) identify each affiliation or business relationship described by Subdivision (1) with respect to which the person filing the questionnaire receives, or is likely to receive, taxable income that:

(A) is received from, or at the direction of, a local government officer of the local governmental entity; and

(B) is not received from the local governmental entity;

(4) describe each affiliation or business relationship with a corporation or other business entity with respect to which a local government officer of the local governmental entity:

(A) serves as an officer or director; or

(B) holds an ownership interest of 10 percent or more;

(5) describe each affiliation or business relationship with an employee or contractor of the local governmental entity who makes recommendations to a local government officer of the local governmental entity with respect to the expenditure of money;

(6) describe each affiliation or business relationship with a person who:

(A) is a local government officer; and

(B) appoints or employs a local government officer of the local governmental entity that is the subject of the questionnaire; and

(7) describe any other affiliation or business relationship that might cause a conflict of interest.

(d) A person described by Subsection (a) shall file an updated completed questionnaire with the appropriate records administrator not later than:

(1) September 1 of each year in which an activity described by Subsection (a) is pending; and

(2) the seventh business day after the date of an event that would make a statement in the questionnaire incomplete or inaccurate.

(e) A person is not required to file an updated completed questionnaire under Subsection (d)(1) in a year if the person has filed a questionnaire under Subsection (c) or (d)(2) on or after June 1, but before September 1, of that year.

(f) A person commits an offense if the person violates this section. An offense under this subsection is a Class C misdemeanor.

(g) It is a defense to prosecution under Subsection (f) that the person filed the required questionnaire not later than the seventh business day after the date the person received notice of the violation.

**Tex. Local Gov't Code § 176.001 (2005)**

§ 176.001. Definitions

In this chapter:

(1) "Commission" means the Texas Ethics Commission.

(2) "Family member" means a person related to another person within the first degree by consanguinity or affinity, as described by Subchapter B, Chapter 573, Government Code.

(3) "Local governmental entity" means a county, municipality, school district, junior college district, or other political subdivision of this state or a local government corporation, board, commission, district, or authority to which a member is appointed by the commissioners court of a county, the mayor of a municipality, or the governing body of a municipality. The term does not include an association, corporation, or organization of governmental entities organized to provide to its members education, assistance, products, or services or to represent its members before the legislative, administrative, or judicial branches of the state or federal government.

(4) "Local government officer" means:

(A) a member of the governing body of a local governmental entity; or

(B) a director, superintendent, administrator, president, or other person designated as the executive officer of the local governmental entity.

(5) "Records administrator" means the director, county clerk, municipal secretary, superintendent, or other person responsible for maintaining the records of the local governmental entity.
