### El Paso County Code of Ethics Training Affidavit

(This form must be signed by an officer, principal, or individual authorized to bind the company under a contract with the County.)

IN COMPLIANCE WITH CHAPTER 161 OF THE TEXAS LOCAL GOVERNMENT CODE, ANY VENDOR INVOLVED IN A SINGLE PROCUREMENT EXCEEDING \$50,000 MUST COMPLETE THE ENCLOSED ETHICS TRAINING BEFORE SUBMITTING A BID OR PROPOSAL WITH THE COUNTY OF EL PASO.

Purpose: The stability of democracy depends upon the continuing consent of the governed, which in turn depends upon the trust the electorate holds for its government. The Ethics Commission of the County of El Paso, Texas, in concert with elected county officials, as well as leaders of the various county departments, recognizes the need to maintain the public trust and confidence in the workings of county government and thus adopts this Code of Ethics.

#### What is a vendor:

Any person or their representative or employee whose goods and services are purchased under the terms of a purchase order or contractual agreement with the county; and any other persons doing business with the County.

Procurement: In advising upon, discussing, recommending, and/or granting any County purchases, bids or contracts, County public servants shall inform themselves about their financial interests, and shall make a reasonable effort to inform themselves about the financial interest of their family members.

County public servants shall excuse themselves from exercising influence, participating in, discussing, recommending, and/or granting of any County purchases, bids, or contracts if they or a family member have a substantial financial interest.

Private Communication: No member of the El Paso County Commissioners Court, County Elected Officials/Department Heads or the El Paso County Hospital District Board of Managers shall permit any vendor, its lobbyists, representative, or employee to communicate with him privately regarding any procurement of items by the County or the Hospital District from the date that the bid, RFP, or RFQ is authorized or released, whichever is first. No private communication regarding the purchase shall be permitted by a member of the Commissioners Court, a county elected official/department head, or

the hospital district board of managers until the procurement process is complete and a purchase order is granted or a contract is entered into.

Members of the Commissioners Court, county elected officials/department heads and the board of managers shall make a reasonable effort to inform themselves regarding procurements and shall have a duty to inquire of vendors, their lobbyists, representatives, or employees, the nature of the private communication being sought prior to engaging in any communication.

This prohibition against private communication with vendors, their lobbyists, representatives, or employees shall apply to commissioners court approval of hospital district purchases.

# Sex Offender Therapy for Adult Probation

#### I. PURPOSE

The El Paso County Community Supervision & Corrections Department (Adult Probation) is seeking a qualified company to provide treatment for adults referred to the program for sexually offensive and sexually abusive behavior. El Paso County CSCD (hereforth referred to as "Department") seeks to award a one-year contract for sex offender therapy services, with the option to renew the contract on a year-to-year basis, not to exceed five (5) contract years.

#### **SCOPE OF WORK**

- 1. Service provider must have been in the business of providing sex offender therapy for a minimum of five (5) years.
- 2. Service provider shall provide qualified staff to implement this project. Staff shall be licensed in the State of Texas as cited in the Occupations Code Title 3. Health Professions, Subtitle A. Provisions Applying to Health Professions Generally, Chapter 110 Council on Sex Offender Treatment, Subchapter A. General Provisions, Sec. 110.001 Definitions. (7) Sex offender treatment provider" means a person, licensed by the council and recognized based on training and experience to provide assessment and treatment to adult sex offenders or juveniles with sexual behavioral problems who have been convicted, adjudicated, awarded deferred adjudication, or referred by a state agency or a court, and licensed in this state to practice as a physician, psychiatrist, psychologist, psychological associate, provisionally licensed psychologist, licensed professional counselor, licensed marriage and family therapist, licensed marriage and family associate, licensed clinical social worker, or advanced practices nurse recognized as a psychiatric clinical nurse, specialist or psychiatric mental health nurse practitioner, who provides mental health or medical services for rehabilitation of sex offenders. A copy of such license shall be provided to department prior to initiating services.

Service provider shall ensure that all staff providing direct services will have and maintain the specific license(s) and/or certification(s) during the term of the contract. Licenses and/or certifications shall be made available for review by the Department and/or Texas Community Justice Assistance Division (CJAD) upon request.

- 3. Service provider shall provide therapeutic services in the client's language of literacy.
- 4. Service provider shall provide individualized and group counseling services to individuals referred by the department. Service provider shall, provide all necessary personnel, equipment, materials, supplies, facilities, and services to meet the specifications described of this RFP.
- 5. The program's ultimate treatment goal shall be to reduce the tendencies of future sexually abusive behavior. In order to reach this goal, the Client must: 1) Accept responsibility for his own behavior without excuses, rationalizations, minimization or projection; 2) Increase client's awareness to understand the consequences of his sexually offensive behavior on the victim(s) and/or others; 3) Identify factors that influence and perpetuate offending behaviors, i.e. describe his sex offender cycle; 4) Develop more appropriate coping mechanisms to

reduce the possibility of further sexual abuse and to increase the likelihood of a satisfactory and productive life while respecting the rights of others; (i.e. develop an individualized relapse prevention plan).

- 6. Service provider will establish and implement Policies & Procedures for clients entering treatment to include:
  - a) Initial assessment;
  - b) Group treatment contract;
  - c) Policy Handbook and participation requirements for the client's use;
  - d) Timely recording of client's progress notes, costs, attendance (including no-show fees);
  - e) Inappropriate group candidates, referral to Community Supervision Officer; and
  - f) Recommendation for clinical polygraph.

If service provider fails to establish policies sufficient for compliance of this section, department has the right to determine the appropriate payment for services, at its discretion.

#### 7. Assessment Phase

The service provider shall provide a comprehensive clinical interview of each referred client, review of other reports and evaluation as available, completion of questionnaires, and an objective measure of sexual interest; the Abel Assessment. Individual treatment goals are developed by therapist based on individual client assessment and Abel Assessment results. Polygraph exam may be required. Provider shall conduct assessment within two weeks of referral.

#### 8. Individualized Plan

Service provider shall prepare a written individualized plan for each client. The plan shall be developed by service provider's staff in conjunction with the conditions of supervision for that client, in coordination with the client's needs and the needs of the department. The individualized plan shall be forwarded to the department no later than 10 days after the completion of the initial assessment;

- a) The individualized plan shall specify individual client problems and procedures for attaining change with behavioral outcomes;
- b) Progress reports shall be submitted to the department no later than the 10th of each month. Progress reports shall contain a brief narrative of each client's work in all sessions and progress toward goals. If the service provider fails to submit the progress reports by the 10<sup>th</sup> of each month, the current invoice payment shall be withheld until the time that progress notes are received;

c) The individualized plan shall be reviewed by both the service provider and department staff on a routine basis to determine necessary modifications of treatment;

#### 9. <u>Intensive Treatment Phase</u>

Clients work on individual treatment goals in a group setting. The group treatment content is divided into ten (10) different psycho-educational modules of six sessions each. Each group meets weekly for one and one- half (1½) hour sessions with a maximum of twelve (12) participants. Service provider shall provide treatment, for the full allotted time, to all clients referred by the department.

#### 10. Reassessment Phase

Upon conclusion of the Intensive Treatment Phase, service provider evaluates whether the client has met his treatment goals and is ready for maintenance phase. Reassessment is conducted in individual session(s) and may include repeat of the Abel Assessment.

#### 11. Maintenance Phase

Service provider shall prepare a Relapse Prevention Plan for each client. Services are conducted in a group setting to review and reinforce the relapse prevention plan. During maintenance the client meets with the service provider on a monthly basis for one year, bimonthly for the second year and quarterly for the third year. The maintenance group frequency can be kept at a monthly basis and/or extended should the client, therapist or community supervision officer deem it necessary.

#### 12. Discharge Plan

The service provider shall develop a discharge plan for each client after the completion of the (third year) quarterly Maintenance Phase of treatment.

13. Any abrupt termination of services to a client resulting from a violation of major rules shall be transmitted to department staff within 72 hours;

#### 14. Optional Services

- Individual Therapy: For those clients needing more intensive treatment that cannot be managed in a group setting only.
- Family Therapy: For clients and their families to address issues with the family that would negatively impact the client's treatment and remains unresolved.
- 15. Court Testimony Service provider agrees to provide testimony in court, if required by the Department, at no additional cost.
- 16. Coordination with Department Service provider shall coordinate the following tasks with assigned department staff and shall proceed upon approval by department:

- a) Performance of all sex offender services;
- b) Services to special needs clients or those with mental impairment Develop and implement procedures for services (or referrals) for clients with dual diagnosis and/or mental and physical disabilities.
- c) All individual, group, family, and educational sessions;
- d) All admissions and discharges from the service;
- e) All changes in the intensity of services to be offered to a client;
- f) All requests for a referral for special treatment;
- g) Identify needs of clients that are beyond the scope of the service provider's services and make appropriate referrals in such circumstances;
- h) All service provider therapy sessions will be held at facilities agreed to by both department and the service provider.
- 17. Service provider shall submit the monthly invoice, on department approved forms by the tenth (10) day of each month.
- 18. No-Shows Department will not pay for clients who fail to attend sessions or meetings. Service provider must notify department of no-shows by Friday of each week.
- 19. Availability of Funds The resulting contract for services is subject to the availability of state funds as appropriated by the State Legislature and as made available to the department by the Texas Department of Criminal Justice Community Justice Assistance Division (TDCJ-CJAD) for the express purpose of providing the services specified herein.

#### 20. Cost:

- a) Cost per therapeutic group session
- b) Cost per individual per hour
- c) Cost for conducting each Abel Assessment
- d) Optional Services Cost per session Individual Therapy as described in Item #14
- e) Optional Services Cost per session Family therapy as described in Item #14

Above costs include the therapist, assessments and screening instruments and recommendation for services/interventions to address issues. Costs to include all typed and signed documentation/reports to the department. Administrative expenses and communications with the department, the courts, referral source, or other agencies are considered part of the cost per therapy and may not be billed as a separate cost. At no time

will the department pay for services when other payments for the client's treatment have been provided.

#### II. PROPOSAL SUBMISSION

One (1) original proposal plus six (6) electronic copies in PDF format on a CD or flash drive must be received by the El Paso County Purchasing Department at the address indicated on the cover page of the Request for Proposal pack no later than <u>Wednesday</u>, <u>June 22</u>, <u>2016</u>, <u>at 2:00 p.m. Mountain Daylight Savings Time</u>. A representative at the Purchasing Department will date-stamp and time-stamp every proposal received immediately upon receipt. All proposals received before the proposal submission deadline will be kept in a secure location at until the due date and time.

The applicant's original proposal must be unbound, on white 8 ½ x 11" paper, no smaller than 12 point font black. Proposals shall not exceed 25 pages. It may be necessary to reproduce the original application to provide sufficient copies for review purposes. Therefore, the applicant should not include anything that cannot be photocopied using automatic processors. Such items include anything stapled, folded, pasted, or in a size other than 8 ½" x 11" on white paper and heavy or lightweight paper which could disable the photocopy machine and/or become destroyed. Odd sized attachments of any kind will not be copied or sent to reviewers. Excessive or over-sized material, e.g., posters, videotapes, or audiotapes should not be included. Documents may not be photo-reduced or have type closer than 15 characters per inch. Furthermore, only one side of each page should have printing.

#### REQUIRED PROPOSAL FORMAT

Every sheet of the proposal must have a page number. It is also requested that pages be numbered consecutively from beginning to end (for example, page 1 for the Cover Page, page 2 for Letter of Transmittal, page 3 for the Table of Contents, etc.). Any appendices should be labeled and separated, and the page numbers should be continued in the sequence.

The proposal must be organized and indexed in the following format and must contain, at a minimum, all listed items in the sequence indicated.

#### A. COVER PAGE

Each proposal must have the "El Paso County Signature Page" as the cover page. The cover page must:

• Identify the RFP (i.e., Proposal for the El Paso County CSCD Sex Offender Therapy);

- Identify the applicant organization;
- Identify the applicant organization's contact person,
- Identify the applicant organization's address, phone, FAX, and
- Indicate the date of the proposal.

#### B. LETTER OF TRANSMITTAL

A Letter of Transmittal must be on official business letterhead and must accompany each proposal.

The Letter of Transmittal must:

- Identify the applicant organization and contact person;
- Identify the name and title of the person authorized by the organization to contractually obligate the organization;
- Identify the legal status of the submitting organization (proprietorship, corporation, non/for-profit, etc.).
- State the number of years the organization has been in the business of providing sex offender therapy and treatment.
- Include federal tax number;
- Identify the name, title, telephone and FAX number of the person to be contacted for clarification;
- Explicitly indicate acceptance of all requirements of the RFP;
  - 1. be signed by the person authorized to contractually obligate the organization;
  - 2. acknowledge receipt of any and all amendments to this RFP;

#### C. TABLE OF CONTENTS

Immediately following the letter of transmittal, the applicant is required to provide a table of contents that identifies all subsequent sections and pages.

#### D. PROPOSAL NARRATIVE

1. Response to the Scope of Work - Describe your organization's qualifications and experience in providing sex offender therapy and treatment.

- 2. In addition, explain your knowledge and understanding of and experience with:
  - a) Working with Adult Probation Departments in the State of Texas;
  - b) Working with related judicial entities (for example: public defenders, county attorneys, Probation Officers, court judges);
  - c) Familiarity with dual diagnosis in adults;
  - d) Familiarity with various evidence based and/or best practices regarding therapeutic techniques and modalities that will be utilized;
  - e) Providing services in the individual's primary language.
- 3. Provide in detail how the organization will address, incorporate and coordinate all the therapeutic services described in the Request for Proposal's to include:
  - a) Group therapeutic services
  - b) Individual therapeutic services
  - c) Abel Assessment

Services should be geared to address the high level needs and risks associated with adults referred to the sex offender program.

4. Identify the therapist(s) that will conduct the individual, group counseling services, and the Abel assessments. List their qualifications and experience in providing this type of service. If applicable, identify any other professional staff and their qualifications and experience.

#### E. REFERENCES

Provide three (3) references of agencies whom the company has provided similar services as described in this RFP. Provide agency name, address, phone number, and contact name.

#### **PROPOSAL EVALUATION**

A representative from the El Paso County Purchasing Department will open the proposals immediately after the deadline and will record them. A representative for the West Texas CSCD will perform a preliminary review of the proposals to determine compliance with the mandatory requirements of the RFP. The El Paso County Evaluation Committee will review all proposals and evaluate each according to the evaluation criteria.

All material submitted in response to this RFP becomes the property of El Paso County and West Texas CSCD. As a political subdivision of the State of Texas, the County is governed by the Texas Public Information Act, Chapter 552, Texas Government Code.

If the Offeror considers any section or part of their proposal to contain confidential or proprietary information, such section or part shall be clearly marked and identified. In the event the County receives a request under the Public Information Act for Confidential Information as identified by Offeror, the County shall promptly notify the Offeror. It is expressly agreed that the County may request a determination from the Attorney General of the State of Texas in regard to the application of the Public Information Act to the requested information and whether the information is to be made available to the public. It is further agreed that County, its officers and employees shall have the right to rely on the determinations of the Texas Attorney General, and that County, its officers and employees shall have no liability to Offeror for disclosure to the public in reliance on a decision by the Attorney General. Nothing in this RFP shall require County or Offeror to violate the terms of the Public Information Act.

The El Paso County CSCD shall have the right to use any or all ideas contained in the proposal. Acceptance or rejection of a proposal shall not affect this right.

Proposals shall be evaluated using the following weighted criteria. It is important that proposals address each item in sufficient detail to provide the best possible evaluation:

#### III. SPECIAL CONDITIONS

- 1. **Health and Safety:** Service provider shall ensure that adequate measures are taken to protect the health and safety of each defendant while receiving services.
- 2. **Duties and Obligations:** Service provider shall provide the services in compliance with applicable federal and state law, including all constitutional, legal and court ordered requirements, whether now in effect or hereafter effected or implemented. Department policies, and unless otherwise required in this agreement, shall be free to establish procedures such that the services attain the goals established by the department policies, provided that any such deviations are approved in writing by department prior to their implementation.
- 3. **Visitation by State Employees:** Service provider shall at all times allow employees/agents of the Governor, members of the Legislature and all other members of the Executive and Judicial branches of the State of Texas, the Contract Monitor, and any other persons designated by the department and/or the Texas Board of Criminal Justice to monitor the delivery of services.
- 4. **Confidentiality:** When applicable, records of identity, diagnosis, prognosis, or treatment of any client through this agreement shall be confidential and may be disclosed only in accordance with applicable laws. No information may be released without the Client's written consent as documented by a signed information release form. Service provider shall notify department in writing if any legal process requires disclosure of a client's record and shall obtain written acknowledgment of same from department's authorized personnel.
- 5. **No Subcontractors:** No subcontractors may be utilized by service provider unless department has furnished prior written approval thereof. The use of all subcontractors initiated after the start of this agreement shall be in a written amendment.
- 6. **Placement of Clients:** Department shall refer, remove, or transfer a Client to and from the service provider's services, at any time, from treatment without consultation of service provider. Department will use the recommended guidelines for the Inter-Program Transfer of Sex Offenders when possible and will inform service provider if a client is removed or transferred.
- 7. **Record Retention:** All records shall be the property of department. All records (electronic or paper) pertinent to the provisions of services hereunder shall be retained by the service provider for a period of five years with the following qualification: If any audit, litigation or claim is started before the expiration of the five-year period, the records shall be retained until all audits, litigation, claims, or other findings involving the records have been resolved. The retention period for all records begins after department the final payment in accordance with this agreement. At the end of the five-year period, service provider will request disposition instructions from department. Department shall not deny service provider access, use, or copies of records in the event of audit, litigation, or claim because of Service provider's responsibility to a governing board.

- 8. **Policies and Procedures:** The services for clients shall include policies and procedures for how services are selected for and/or by clients, participation in services, termination of services, and for the documentation and notification of any significant incidents involving clients receiving such services. Services for clients, reflected in policy and procedure or that is covered in the acceptable standards of practice shall be available for review and approval by department prior to implementation, include service criteria, participation in treatment, safety and security, supervision of clients, referral activities, documentation of services provided and incident reporting and resolution. Deviations from such policies and procedures or acceptable standards of practice, whether temporary or permanent, require prior written approval from department.
- 9. **Termination at Will:** Either party may terminate this agreement for any reason whatsoever, without cause and at any time, by furnishing to the other party thirty (30) days prior written notice. Department only obligation for terminating this agreement pursuant to this section shall be the payment to service provider of Payments earned hereunder up to the date of termination. Service provider's only obligation for terminating this agreement pursuant to this section shall be to provide services until the date of termination. Neither service provider nor department shall thereafter be entitled to any other bonus, damage, settlement or compensation for expected or lost profits or otherwise.

#### IV. ADMINISTRATION AND FISCAL SYSTEM

- 1. **Administrative Controls:** Service provider shall establish, document and maintain adequate administrative and internal controls to ensure that only allowable services are billed.
- 2. **Governing Board Responsibility:** The appropriate governing board or entity of Service provider shall bear full responsibility for the integrity of the program budget, including accountability for all payments, compliance with department policies, and applicable federal and state laws and regulations, and TDCJ-CJAD. Ignorance of any agreement provisions or other requirements contained herein shall not constitute a defense or basis for waiving or appealing such provisions or requirements.
- 3. **Conflict of Interest:** Service provider shall establish safeguards to prohibit members of the governing board, contractual personnel, consultants, volunteers, and employees from using their positions for a purpose that is or gives the appearance of being motivated by a desire for private gain for themselves or others, particularly those with whom they have family or business relationships.
- 4. **Remuneration:** Staff of Service provider shall not pay or receive any commission, consideration, or benefit or any kind related to the referral of a client for services or engage in fee-splitting with other professionals.
- 5. **Disclosure:** Service provider is required to immediately or timely, as the case may be, disclose to department and TDCJ-CJAD the following:

- a. If any person who is an employee or director of Service provider is currently registered or is required to register as a lobbyist under Texas Government Code Chapter 304, at any time during the term hereof, Service provider shall provide initial notification and shall provide to department and TDCJ-CJAD timely copies of all reports filed with the Texas Ethics Commission as required by Chapter 305;
- b. If any person who is an employee, subcontractor, or director of service provider is or becomes an elected official (i.e., an elected or appointed state official or member of the judiciary, or a United States Congressman or Senator), service provider shall provide initial notification and timely notification during the term hereof;
- c. If Service provider receives funds other than, or in addition to, those paid by department for services hereunder, it being agreed that in such event, department shall be entitled to reimbursement of such portion of such funds as it is attributed to the provision of Services hereunder. As used in this subparagraph, the term funds means any amounts received by service provider on behalf of any client who is receiving services from service provider;
- d. Report any actions or citations by Federal, State, or local governmental agencies that may affect service provider's licensure status or its ability to provide services hereunder.
- 6. Withhold Payments: Department may withhold payments for any ineligible claims including inaccurate, inadequate or untimely monthly invoices until such time as the ineligible, inadequate or untimely claim is resubmitted and/or corrected by service provider. Department reserves the right to suspend client placements, withhold service provider payments, or require the return of payments in the case of noncompliance with department Policies, including, but not limited to, recurring acts of noncompliance and expenditures for unallowable costs. A list of unallowable costs are included as Exhibit A.
- 7. **Accounting Records:** Service provider agrees to maintain a specific accounting or bookkeeping system specifically identifying the revenue associated with this agreement in accordance with fund accounting principles.
- 8. **Audit of Records:** Service provider agrees to furnish to department and/or TDCJ-CJAD and/or designees such information as may be required relating to the services described in this agreement. Service provider shall permit department and/or TDCJ-CJAD and or their designee to audit/inspect records and reports, review services, and/or evaluate the performance of services at any time. Service provider shall provide reasonable access to all the records, books, reports, and other necessary data and information needed to accomplish review of program activities, and services, including cooperation with department and/or TDCJ-CJAD for the purpose of accomplishing reviews, inspections, and/or audits or program activities and services.
- 9. **Peer or Group-Controlled Meetings:** The service provider shall not, under any circumstances, bill the department for peer or group-controlled meetings and such

- meetings shall not be counted toward the minimum treatment/counseling session requirements set forth herein.
- 10. **Misspent Funds:** The service provider will refund expenditures of the service provider that are contrary to this RFP and deemed inappropriate by the Department or designee.
- 11. **Indemnification:** Service provider shall indemnify and hold the department, the Board of Criminal Justice, the Texas Department of Criminal Justice, the State of Texas, and its officers, agents and employees (hereinafter, collectively referred to as "State") harmless from and against any and all claims arising from the conduct, management or performance hereof, including, without limitation, any and all claims arising from any condition herein or arising from any breach or default on the part of service provider in the performance of any covenant or agreement on its part to be performed, or arising from any act of negligence of service provider, or licensees or arising from any accident, injury or damage whatsoever caused to any person, firm or corporation and from and against all costs, reasonable attorney's fees, expenses and liabilities incurred in or about any such claim, action or proceeding brought against the State by reason of any such claim. In any such action brought against the State, SERVICE PROVIDER, upon notice from the State, shall defend against such action or proceeding by counsel satisfactory to the State, unless such action or proceeding is defended against by counsel for any carrier of liability insurance provided for herein. The aforementioned indemnification shall not be affected by a claim that negligence of DEPARTMENT, the State, or their respective agents, Service Provider's, employees or licensees contributed in part to the loss or damage indemnified against.

# EXHIBIT A UNALLOWABLE COSTS

Any item unallowable by State or any authorized agency, statute, policy, or procedure including, but not limited to, federal guidelines for operation of for-profit and not-for-profit entities;

Alcoholic beverages;

Bad debts;
Building and Land purchase, rental purchase, lease purchase, renovation;
Cash payments to intended recipients of services;
Equipment items exceeding \$1,000 (CPU, Monitor and Keyboard are one unit) counted as a direct expense toward the program. Such items may be charged to the program only through an approved depreciation methodology.
Expenses or reimbursements to or on behalf of service provider-related entities for allowable indirect costs;
Expenses or costs reimbursed to service provider by other funds with respect to amounts paid by the department for service provider services;
Fines and penalties;
Firearm, firearm components, and ammunition;
Fund-raising; marketing; and advertising (advertising is allowable for personnel vacancies and procurement of goods and services only);
Legislative expenses for payment to any elected official from funds received from the department;
Lobbying;
Payments to or on behalf of individuals related to principals of any service provider-affiliated organization(s) or to their employees, unless as allowable indirect costs or unless specific approval is received from the department; and
Tobacco products.

# General Provisions County of El Paso, Texas

These General Provisions are considered standard language for all County of El Paso BIDS and Request for Proposal documents. If any "specific bid requirements" differ from the General Provisions listed here, the "specific bid requirements" shall prevail.

#### 1. BID/PROPOSAL PACKAGE

- **a.** The request for bid/proposal, general and special provisions, drawings, specifications/line item details, contract documents and the bid/proposal sheet are all considered part of the bid/proposal package. Bids/Proposals must be submitted on the forms provided by the County, including the bid/proposal sheet completed in its entirety and signed by an authorized representative by original signature. Failure to complete and sign the bid/proposal sheet/contract page (s) may disqualify the bid/proposal from being considered by Commissioners' Court. Any individual signing on behalf of the proposer expressly affirms that he or she is duly authorized to tender this bid/proposal and to sign the bid/proposal sheet/contract under the terms and conditions in this bid/proposal. Proposer further understands that the signing of the contract shall be of no effect unless subsequently awarded and the contract properly executed by Commissioners' Court. All figures must be written in ink or typed. Figures written in pencil or with erasures are not acceptable. However, mistakes may be crossed out, corrections inserted, and initialed in ink by the individual signing the bid/proposal. Changes must also be made to any electronic copies submitted. If there are discrepancies between unit prices quoted and extensions, the unit price will prevail. Each bidder/proposer is required to thoroughly review this entire bid/proposal packet to familiarize themselves with the bid/proposal procedures, the plans and specifications for the requested work as well as the terms, and conditions of the contract the successful proposer will execute with the County.
- b. Bid/Proposal must be in the Purchasing Department BEFORE the hour and date specified. Faxed or e-mailed bids/proposals will not be accepted. Late bids/proposals will not be considered under any circumstances.
- **c.** Any bid/proposal sent via express mail or overnight delivery must have the BID/RFP number and title clearly marked on the outside of the envelope or package. Failure to clearly identify your bid/proposal may be cause for disqualification.

#### 2. COMPETITIVENESS AND INTEGRITY

To prevent biased evaluations and to preserve the competitiveness and integrity of such acquisition efforts, proposers are to direct all communications regarding this bid/proposal to the El Paso County Purchasing Agent or assigned designee, unless otherwise specifically noted.

An authorized person from the submitting firm must sign all bids/proposals. The signature acknowledges that the proposer has read the bid/proposal documents thoroughly before submitting a bid/proposal and will fulfill the obligations in accordance to the terms, conditions, and specifications.

Please carefully review this Request for Bid/Proposal. It provides specific information necessary to aid participating firms in formulating a thorough response.

#### 3. BIDDERS'S/PROPOSER'S RESPONSIBILITY

The Bidder/Proposer must affirmatively demonstrate its responsibility. The Bidder/Proposer must also meet the following minimum requirements:

- Have been in business of providing services for a minimum of one (1) years;
- Have adequate financial resources or the ability to obtain such resources as required;
- Be able to comply with all federal, state, and local laws, rules, regulations, ordinances and orders regarding this Request for Bid/Proposal;
- Have satisfactory record of performance;
- Have a satisfactory record of integrity and ethics; and
- Be otherwise qualified and eligible to receive an award.

#### 4. REJECTION OF BIDS/PROPOSALS

The County, acting through its Commissioners' Court reserves the right to: (1) reject any and all bids/proposals and waive any informality in the bids/proposals received; (2) disregard the bid/proposal of any proposer determined to be not responsible. The County further reserves the right to reject any bid/proposal due to failure of performance on deliveries as determined in writing by the County Purchasing Agent.

#### 5. RESTRICTIVE OR AMBIGUOUS SPECIFICATIONS

It is the responsibility of the prospective proposer to review the entire invitation to bid/proposal packet and to notify the Purchasing Department if the specifications are formulated in a manner that would restrict competition or appear ambiguous. Any such protest or question(s) regarding the specifications or bid/proposal procedures must be received in the Purchasing Department no less than seventy-two hours prior to the time set for bid/proposal opening. Vendors are to propose as specified herein or propose an approved equal. The mention of any brand name in the specifications is not intended to be restrictive, but is intended to describe the general features and requirements (or equivalent) that the County of El Paso is seeking.

Under Local Gov't Code Section 262.005 and Health & Safety Code Section 361.426, the County is required to give preference to products made of recycled materials if they meet specs. The County is also required to encourage the use of recycled products in developing new procedures and specs. They are also required to eliminate procedures and specifications that explicitly discriminate against products made of recycled materials.

#### 6. SUBSTITUTES

It is not the County's intent to discriminate against any material of equal merit to those specified however, should the proposer desire to use any substitutions, prior written approval shall be obtained from the County Purchasing Agent sufficiently in advance in order that an addendum might be issued.

#### 7. EXCEPTIONS TO BID/PROPOSAL

The proposer will list on a separate sheet of paper any exceptions to the conditions of the bid/proposal. This sheet will be labeled, "Exceptions to Bid/Proposal Conditions", and will be attached to the bid/proposal. If no exceptions are stated, it will be

understood that all general and specific conditions will be complied with, without exception.

The Bidder/Proposer must specify in its bid/proposal any alternatives it wishes to propose for consideration by the County. Each alternative should be sufficiently described and labeled within the bid/proposal and should indicate its possible or actual advantage to the program being offered.

The County reserved the right to offer these alternatives to other proposers.

#### 8. PRICING

Bid/Proposals for equipment shall offer new (unused) equipment or merchandise unless otherwise specified. Quotes F.O.B. destination. If otherwise, show exact cost to deliver (merchandise only). Bid/Proposal will be either lump sum or unit prices as shown on the bid/proposal sheet. The net price will be delivered to the El Paso County, including all freight or shipping charges. In case of error in extension, unit prices shall govern. BID/RFP subject to unlimited price increases will not be accepted. The County is tax exempt and no taxes should be included in your bid/proposal.

Unless prices and all information requested are complete, bid/proposal may be disregarded and given no consideration.

In case of default by the contractor, the County may procure the articles or services from other sources and may deduct from any monies due, or that may thereafter become due to the contractor, the difference between the price named in the contract of purchase order and the actual cost thereof to the County. Prices paid by the County shall be considered the prevailing market price at the time such purchase is made. Periods or performance may be extended if the facts as to the cause of delay justify such extension in the opinion of the Purchasing Agent and the Commissioners' Court.

#### 9. TAX EXEMPTION

Pursuant to Section 151.309 of the Texas Tax Code, El Paso County qualifies for exemption from sales, excise and use taxes imposed under the Limited Sales, Excise, and Use Tax Act, which is codified at Chapter 151 of the Texas Tax Code. In accordance with Section 151.309, a taxable item sold, leased, or rented to, or stored, used, or consumed by the County is exempt from the taxes imposed under Chapter 151.

#### 10. MODIFICATION OF BIDS/PROPOSALS

A bidder/proposer may modify a bid/proposal by letter at any time prior to the submission deadline for receipt of bids/proposals. Modification requests must be received prior to the submission deadline. Modifications made before opening time must be initialed by bidder/proposer guaranteeing authenticity. Bids/Proposals may not be amended or altered after the official opening with the single exception that any product literature and/or supporting data required by the actual specifications, if any, will be accepted at any time prior to the Commissioners' Court consideration of same. No substitutions or cancellations for merchandise will be permitted without written approval of the County Purchasing Agent.

#### 11. SIGNATURE OF BIDS/PROPOSALS

Each bid/proposal shall give the complete mailing address of the Bidder/Proposer and be signed by an authorized representative by original signature with the authorized representative's name and legal title typed below the signature line. Each bid/proposal shall include the Bidder's/Proposer's Federal Employer Identification Number (FEIN), failure to sign the Contract page(s) and bid/proposal response sheet will disqualify the bid/proposal from being considered by the County. The person signing on behalf of the Bidder/Proposer expressly affirms that the person is duly authorized to render the bid/proposal and to sign the bid/proposal sheets and contract under the terms and conditions of this BID/RFP and to bind the Bidder/Proposer thereto and further understands that the signing of the contract shall be of no effect until it is properly placed on the Commissioner's Court agenda, approved in open Court, authorized to be executed by the County Judge, and fully executed by both parties.

#### 12. AWARD OF BID/PROPOSALS-EVALUTATION CRITERIA AND FACTORS

#### **Pursuant to the Texas Local Government Code**

Bids shall be awarded to the responsible bidder that submits the lowest and best bid.

**Bid/Proposals** will be made to the responsible proposer whose bid/proposal is determined to be the best evaluated offer demonstrating the best ability to fulfill the requirements set forth in this Request for Bid/Proposal. The prices proposed will be considered firm and cannot be altered after the submission deadline. **The proposed** cost to the County will be considered firm, unless the County invokes its right to request a best and final offer and cannot be altered after the submission deadline.

The County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this BID/RFP and may discontinue its efforts under this BID/RFP for any reason or no reason or solely for the County's convenience at any time prior to actual execution of the contract by the County. County reserves the right to accept or reject all or any part of the bid/proposal, waive minor technicalities, or to award by item or by total bid/proposal. Price should be itemized.

# A Bidder/Proposer whose bid/proposal does not meet the mandatory requirements set forth in this BID/RFP will be considered noncompliant.

Each Bidder/Proposer, by submitting a bid/proposal, agrees that if its bid/proposal is accepted by the Commissioners' Court, such Bidder/Proposer will furnish all items and services upon the terms and conditions in this BID/RFP and contract.

Contractor shall submit to the County, for approval, within ten (10) days from notice of contract award, all Certificates of Insurance evidencing the required coverage as described under Insurance in the schedule of the Requests for Bids/Proposals.

#### 13. PUBLIC INFORMATION ACT

The parties agree that the County is a governmental body for purposes of the Public Information Act, codified as Chapter 552 of the Texas Government Code and as such is required to release information in accordance with the Public Information Act. Bidder/Proposer agrees that it has marked any information that it considers to be confidential, proprietary, and/or trade secret in its bid/proposal. County agrees to

provide notice to Bidder/Proposer in accordance with the Public Information Act in the event the County receives a request for information under the Public Information Act for information that the Proposer has marked as confidential, proprietary, and/or trade secret.

#### 14. RESULTANT CONTRACT

The resultant contract shall become effective upon the Commissioners' Court execution of the same. The contract documents shall consist of the contract, the general and special provisions, the drawings, bid/proposal package, any addenda issued, and any change orders issued during the work.

The criteria utilized for determining responsibility of bidder/proposer(s) includes, but is not limited to, the proposer's experience, skill, ability, business judgment, financial capacity, integrity, honesty, possession of the necessary facilities or equipment, previous performance, reputation, promptness, and any other factor deemed relevant by the County to determine whether a bidder/proposer is responsible. The term of the resultant contract will begin as stated in the contract executed by the Commissioners' Court and will terminate on the date specified in the contract unless terminated earlier as herein set forth.

#### 15. ESTIMATED QUANTITIES

Any reference to quantities shown in the Request for Bids/Proposals are an estimate only. Since the exact quantities cannot be predetermined, the County reserves the right to adjust quantities as deemed necessary to meet its requirements.

#### 16. CONTRACTOR INVESTIGATION

Before submitting a bid/proposal, each contractor shall make all investigations and examinations necessary to ascertain all site conditions and requirements affecting the full performance of the contract and to verify any representations made by the County upon which the contractor will rely. If the contractor receives an award as a result of its bid/proposal submission, failure to have made such investigations and examinations will in no way relieve the contractor from its obligation to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim whatsoever by the contractor for additional compensation.

#### 17. NO COMMITMENT BY COUNTY

This Request for Bid/Proposal does not commit the County to award any costs or pay any costs, or to award any contract, or to pay any costs associated with or incurred in the preparation of a bid/proposal to this request, or to procure or contract for services or supplies.

#### 18. BEST AND FINAL OFFERS

In acceptance proposals, the County reserves the right to negotiate further with one or more of the contractors as to any features of their proposals and to accept modifications of the work and price when such action will be in the best interest of the County. This includes solicitations of a Best and Final Offer from one or more of the proposers. If invoked, it allows acceptable proposers the opportunity to amend, change or supplement

their original proposal. Proposers may be contacted in writing requesting that they submit their best and final offer. Any such best and final offer must include discussed and negotiated changes.

#### 19. SINGLE BID/PROPOSAL RESPONSE

If only one (1) bid/proposal is received in response to the Request for Bids/Proposals, a detailed cost bid/proposal may be requested of the single contractor. A cost/price analysis and evaluation and/or audit may be performed of the cost bid/proposal in order to determine if the price is fair and reasonable.

#### 20. REJECTION/DISQUALIFICATION OF BIDS/PROPOSALS

El Paso County reserves the right to reject any or all bids/proposals in whole or in part received by reason of this bid/proposal package and may discontinue its efforts for any reason under this bid/proposal package at any time prior to actual execution of the Contract by the County. Bidders/Proposers may be disqualified and rejection of bid/proposals may be recommended to the Commissioners' Court for any of (but not limited to) the following causes:

- A. Failure to use the bid/proposal form(s) furnished by the County, if applicable.
- B. Lack of signature by an authorized representative that can legally bind the company on the bid/proposal form.
- C. Failure to properly complete the bid/proposal.
- D. Bids/proposals that do not meet the mandatory requirements.
- E. Evidence of collusion among bidders/proposers.

#### 21. CHANGES IN SPECIFICATIONS

If it becomes necessary to revise any part of this bid/proposal, a written notice of such revision will be posted on the County Purchasing website. The County is not bound by any oral representations, clarifications, or changes made in the written specifications by the County's employees, unless such clarification or change is posted on the County Purchasing website. It shall be Bidder's/Proposer's responsibility to check the website prior to the bid/proposal opening date to verify whether any addendums have been posted.

#### 22. BID/PROPOSAL IDEAS AND CONCEPTS

The County reserves the right to adopt or use for its benefits, any concept, plan, or idea contained in any bid/proposal.

#### 23. BID/PROPOSAL DISCLOSURES

Results of bids/proposals for the purchase of goods, materials, general services and construction are considered public information at the time of the bid/proposal opening. All information contained in the bid/proposal response is available for public review.

The Proposal for Services: Only the names of those who submitted proposals will be made public information until an award is made by Commissioners' Court and contract executed by the parties. No price, staffing or other proposal information will be released. Proposers are requested to withhold all inquiries regarding their proposal or other submissions until after an award is made. No communication is to be had with any

County employee, other than the Purchasing Agent, regarding whether a proposal was received. Violations of this provision may result in the rejection of a proposal.

#### 24. WITHDRAWAL OF BID/PROPOSAL

Bidders/Proposers may request withdrawal of a sealed bid/proposal prior to the scheduled bid/proposal opening time provided the request for withdrawal is submitted to the Purchasing Agent in writing. No bids/proposals may be withdrawn for a period of sixty (60) calendar days after opening of the bids/proposals.

#### 25. INDEMNIFICATION

A. The contractor shall agree to assume all risks and responsibility for, and agrees to indemnify, defend, and save harmless, the County, its elected and appointed officials and department heads, and its agents and employees from and against all claims, demands, suits, actions, recoveries, judgments, and costs and expenses including reasonable attorney's fees for the defense thereof in connection therewith on account of the loss of life property or injury or damage to the person which shall arise from contractor's operations under this contract, its use of County facilities and/or equipment or from any other breach on the part of the contractor, its employees, agents or any person(s) in or about the County's facilities with the expressed or implied consent of the County. Contractor shall pay any judgment with cost which may be obtained against El Paso County resulting from contractor's operations under this contract.

Contractor agrees to indemnify and hold the County harmless from all claims of subcontractors, laborers incurred in the performance of this contract. Contractor shall furnish satisfactory evidence that all obligations of this nature herein above designated have been paid, discharged or waived. If Contractor fails to do so, then the County reserves the right to pay unpaid bills of which County has written notice direct and withhold from Contractor's unpaid compensations a sum of money reasonably sufficient to liquidate any and all such lawful claims.

B. Pursuant to Texas Local Government Code Section 262.032(b), any successful bidder who is awarded any contract in excess of \$50,000 may be required to execute a performance bond to the County. Said bond shall be in the full amount of the contract and must be furnished within 30 days after the date a purchase order is issued or the contract is signed and prior to commencement of the actual work. A performance bond required pursuant to this section shall be noted in the attached detailed bid specifications or scope of work. This section does not apply to a performance bond required by Chapter 2253, Texas Government Code.

#### 26. PROOF OF INSURANCE

Successful proposer agrees to keep in full force and effect, a policy of public liability and property damage insurance issued by a casualty company authorized to do business in the State of Texas, and in standard form approved by the Board of Insurance Commissioners' of the State of Texas, with coverage provision insuring the public from any loss or damage that may arise to any person or property by reason of services limits of not less than the following sums:

#### CERTIFICATE OF LIABILITY INSURANCE

In the remarks section should include job description or project name and/or number. Successful bidder shall carry in full force Workers' Compensation Insurance Policy (ies), if there is more than one employee, for all employees, including but not limited to full time, part time, and emergency employees employed by the successful bidder. Current insurance Certificates certifying that such policies as specified above are in full force and effect shall be furnished by successful bidder to the County. Insurance is to be placed with insurers having a best rating of no less than A. The Bidder shall furnish the County with certificates of insurance and original endorsements affecting coverage required by these insurance clauses within ten (10) business days of execution of this contract. The certificates and endorsements for each insurance policy are to be signed by a person authorized by the insurer to bind coverage on its behalf. The Bidder shall be required to submit annual renewals for the term of this contract prior to expiration of any policy.

In addition to the remedies stated herein, the County has the right to pursue other remedies permitted by law or in equity. The County agrees to provide Bidder with reasonable and timely notice of any claim, demand, or cause of action made or brought against the County arising out of or related to utilization of the property. Proposer shall have the right to defend any such claim, demand or cause of action

at its sole cost and expense and within its sole and exclusive discretion. The County agrees not to compromise or settle any claim or cause of action arising out of or related to the utilization of the property without the prior written consent of the Bidder. In no event shall the County be liable for any damage to or destruction of any property belonging to the Bidder.

County of El Paso shall be listed as the additional insured on policy certificates and shall be notified of changes to the policy during the contractual period.

#### 27. MANDATORY DISCLOSURES:
