1. Can the County provide a copy of the most recent addendum and plan holders list for this project?

Response: Bidders list has been placed in the Purchasing website: www.epcounty.com ; Purchasing; County of El Paso Texas-Purchasing Department; list of bids; under 21-022.

2. Can the Lochinvar boiler in lieu of the Raypack be offered?

Response: As stated in the bid specifications under the following section:

BRAND NAME

A Brand Name is used to identify the characteristics and level of quality that will satisfy TCJS requirements. Proposed "or equal" units must be of the same quality and comply with the manufacturer's requirements and specifications; physical, functional and /or performance characteristics. The Bidder must state the proposed manufacturer's name and part number and provide documentation sufficient, in the El Paso County Public Works judgement, to permit a determination as to whether the unit bid constitutes an "or equal."

3. Under the system requirements, for the water heater, it states Make: Hi Delta II and Model: 302-C – 902C, that gives 6 different ranges for the BTU's. Which BTU's will be replaced?

Response: The 748,000 BTU will be replaced.

4. Is there a budget amount available for this project?

Response: No, this information is not available at this time.
