On this day, on motion of Commissioner Williams, seconded by Commissioner Gallardo, it is the order of the Commission to approve the recommended changes to Chapter 2, Section 7 Employment - Equal Employment Opportunity, of the El Paso County Sheriff's Office Civil Service Commission Rules and Regulations. After Ludy Velo from Human Resources provided a synopsis and explained policies are being revised to match them to the County's policies and informed the commissioners that this policy was updated by adding a few of the protective classes. Ludy Velo also informed the commission that anything highlighted in yellow was a minor change in addition to the changes presented. Holly Lytle from County Attorney's office explained that anything highlighted in yellow was a correction from the backup that was originally posted. Commissioner Gallardo, asked why the political affiliation was removed and not covered. Ludy Velo from Human Resources explained that anything that is under the protected classes is covered under the El Paso County Affirmative Action Plan and applicable Federal or State Statutes. After Holly Lytle from County Attorney's office responded to the board's concerns and briefly explained that these changes were promoted by Human Resources, but basically under Equal Employment Opportunities these classes are protected by the Federal Statute. Political affiliation is in a separate policy under the Civil Service that are protected, but there are other rules that protect it under certain circumstances, the motion carried by a majority vote of the commission.
