<b>INTERMEDIATE SUICIDE DETECTION AND PREVENTION IN A JAIL SETTING:</b> <b>(TCOLE 3501) (8 hrs.)</b> This course will help the officer take a proactive approach to identifying and preventing suicidal attempts in a jail setting. This course is designed to train the officer in early warning signs and symptoms an inmate may have. This training will make the officer aware of potential liabilities that may occur when suicides are successful in a facility. The officer will additionally become aware of the state and national statistics on suicides in lockups. <b>This course is a TCOLE requirement for Intermediate Jailer Certification.</b> <b>Time 0800-1700</b> <b>Coordinator/Instructor: Ofc. <b>DEFENSIVE DRIVER'S COURSE:</b> <b>(TCOLE 3931) (8 hrs.)</b> This course is designed to familiarize the student with skills that will improve their chances of avoiding future collisions that could result in serious injury and/or death. The students will learn techniques for driving defensively. Per Policy, all personnel authorized by EPCSO to operate a county vehicle must attend a Defensive Driving Course, provided by the Academy, every three (3) years during their employment with the Office. <b>D.W.I. <b>INTERMEDIATE USE OF FORCE FOR PEACE OFFICERS:</b> <b>(TCOLE 2107) (16 hrs.)</b> The student will obtain a basic overview of the terminology and concepts regarding use of force. The student will also obtain information concerning research indicating factors and situations where use of force may be likely. The student will be able to demonstrate on a written objective type examination an understanding of this area to a specified percentage. <b>This course is a TCOLE requirement for Intermediate Peace Officer Certification.</b> <b>Time 0800-1700</b> <b>Coordinator/Instructor: Dep. W. Lamoy/ Dep. J. Sapien</b> <b>Limited to 24 students</b>	11-12	N/A	N/A
<b>HELICOPTER RESPONSE COURSE:</b> <b>(NO TCOLE CREDIT) (2hrs.)</b> In high-risk emergencies, time and safety are critical. Patrol officers are often the first on scene and play a vital role in preparing for the arrival of air medical or law-enforcement helicopters. This course provides officers with the essential knowledge and practical skills to quickly establish, secure, and communicate a safe landing zone (LZ) during critical incidents.  Participants will learn how to identify suitable landing areas, evaluate hazards, coordinate with dispatch and flight crews, and maintain scene safety throughout the operation. The training emphasizes rapid assessment, effective communication, and teamwork to ensure efficient and safe helicopter operations in the field.  <b>This course is ideal for patrol personnel seeking to enhance their readiness for serious emergencies such as major crashes, medical crises, rescues, and tactical deployments. Upon completion, officers will be able to confidently set up and manage a landing zone that meets safety standards for both responders and flight crews.</b> <b>Training Time: 0800-1000</b> <b>Coordinator: Dep. <b>RADAR/LIDAR CERTIFICATION:</b> <b>(TCOLE 2054) (16 hrs.)</b> The purpose of this course is to educate the law enforcement officer on speeding problems, speed enforcement, and different methods of speed measurement. <b>OFFICER STRESS IN CORRECTIONS: (4 hrs.) (TCOLE 2190)</b> Whether it's acknowledged to be factual or not, stress is a silent killer among correctional officers and detention officers. This viewpoint is often challenged by correctional officers who resist the suggestion it can happen to them as they are stronger than the average person working inside a large jail or prison thus immune to such an invasion of the body, spirit, or mind. #### **\*\*Physical Fitness Requirement\*\***

Some courses offered by the El Paso County Sheriff's Office Region VIII Training Academy will require a degree of physical fitness.

**Minimum Level-** This level will consist of walking, stepping, and very light cardiovascular exercise.

**Medium Level-** This level will consist of jogging; minimal levels of calisthenics (i.e. push-ups, sit-ups, side straddle hop); and/or beginning levels of hands-on contact (i.e. PPCT and O.C.).

**Maximum Level-** This level will consist of running; sprinting; advanced calisthenics; and/or advanced levels of hands-on contact (i.e. mobile field force, physical fitness exams).

**Medium and maximum-** These levels will require a blood pressure screening and students who do not pass will not be allowed to participate without a doctor's release on file.
